

Fund Overview

The Waypoint All Weather Alternative Fund is our core public equity portfolio that is designed to deliver superior risk-adjusted returns across market cycles. It is comprised of capital distributors and compounders with a volatility overlay to reduce the impact of market drawdowns.

The strategy provides institutional grade diversification via uncorrelated returns with low volatility & drawdown risk. Our portfolio management team has been managing the strategy for the past 10+ years in segregated accounts and now offer access through the fund with daily liquidity.

Fund Commentary

The Waypoint All Weather Alternative Fund was -4.16% for the month (-9.72% YTD) vs. +7.48% (+7.54% YTD) for the S&P TSX Total Return Index.

Equity markets rebounded aggressively in November based on a softer jobs report and one CPI print coming in at 0.1% below consensus expectations. The market now firmly believes we are past the point of peak rates, the fight against inflation is over and everything is going to get better from here. A mark-to-market decrease in the portfolio's option positions was the cause of this month's negative performance.

From our perspective, where we have line of sight into the health of small businesses and consumers across North America, we have already entered a recession. We believe in the coming quarters, earnings estimates that have largely underpinned equity markets will begin coming down. We believe risks remain elevated. Markets are positioned for a soft landing in the economy, but there is no guarantee that growth will remain resilient after central bank tightening takes effect.

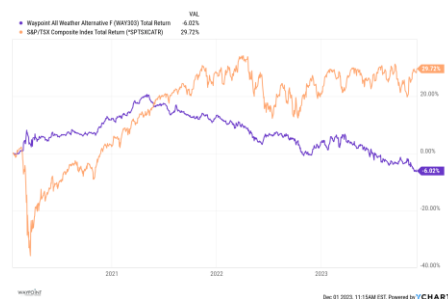
